Meeting called to order by Elaine West at 9:16 am.

Committee Reports –

Building Committee – Progress is being made but due to harsh winter weather an another extension maybe necessitated. No requests have been made but it has been discussed.

OPERATIONS - Snow plowing has been challenging this year. More snow than normal and lots of wind. Darrel has been doing a great job keeping up with it and the bobcat blower has been essential to keeping the car parking lot reasonably open.

The motor and meter on the fuel pump went out late December. Meter and pump motor had to be overhauled. They are back in service but need to monitor the pump motor for possible voltage issues.
